APPLICATION GUIDELINES

Objective:

To assist the students of East Vancouver Community Music School who demonstrate a need for financial assistance with their musical studies.

Criteria:

- a. Applicants must be Canadian citizens or landed immigrants
- b. Bursary recipients must maintain regular attendance and participate in at least one school recital throughout the year
- c. Bursaries over \$100 will be subject to periodic review
- d. Bursaries do not go directly to the recipient but will be applied to their lesson fees with an EVCMS faculty instructor; bursaries are neither transferrable nor refundable.
- e. Incomplete applications will not be considered.

All applicants must submit the following:

1. Completed application form
2. Letter from the student explaining why they want to study music (children under 14 years old may submit a letter written by their parent or guardian)
3. A copy of Canada Revenue Agency Notice of Assessment (form T 451E), (This information will remain confidential and will be destroyed once the application process is complete.)
4. Completed Music Studies budget
5. Letter of recommendation from a teacher or other non-family member

Bursary applications and information submitted will be held in strict confidence by the Bursary Committee.
